Andrew's background

A construction professional with a degree in Social Psychology, Andrew has a distinctive combination of broad commercial experience and an acute understanding of human behaviour.

He has considerable experience working at the interface between commercial and operational disciplines, gained in a variety of senior positions working as a main contractor, supplier and consultant. He understands the mindset of business owners.

A common thread running through Andrew's career is that of 'collaborative practice' – whether through the introduction of a partnering ethos to a medium sized business; the use of web-based technology to encourage project collaboration on large and complex projects, or the use of construction systems to promote greater teamwork – all have involved getting people to work together more effectively.

From 1987–1999, Andrew worked at the front line on construction sites and later, at board level, with a regional building and civil engineering contractor. Following a spell as a freelance consultant in 2000, Andrew was recruited by the Israeli start-up company, iScraper as Director of Client Services. The company pioneered the use of web-based technology to manage construction projects.

As Commercial Director with Outinord SA (2002–2008), a French construction systems supplier who's clients are primarily Developers & House-builders, Andrew was responsible for resolving site-based disputes, settling final accounts and negotiating joint venture agreements.

In 2009 Andrew joined Gleeds, the UK-based international management and construction consultancy, working as part of Gleeds Collaboration Services, before deciding to practice full-time as an Independent Mediator in 2010.

Mediation Training

Andrew trained in Commercial and Workplace mediation with UK Mediation (2010), which is nationally accredited by the Law Society and The Bar Council and is a member of the Civil Mediation Council.

His Family Mediation training was with Key Mediation (2011) and delivered by Tony Whatling. This mediation programme is recognized by the Family Mediation Council (FMC) and the European Family Mediation Forum.
